





A PERSONAL REFECTION ON BECOMING AN OT EXPERT WITNESS

Our assessments identify what functional impact an accident/ clinical negligence has on an individual. Recommendations are based on what they need to put them back in the situation they would have been in had the accident or clinical negligence not occurred. This opens up a whole new world and allows you to be creative; you're not bound by cost, but by what is reasonable. Somek provide comprehensive training to prepare experts for this work.



There is a team of experienced trainers who ensure reports meet the standards expected. Invaluable support is also provided by admin, case handlers, reports and finance teams. Somek also deal with case enquiries to secure instructions. All of this is a huge benefit, as completing the assessment and report is a big enough task in itself!

The Claimant injured his right leg (fractured calcaneus) in a workplace accident. This did not improve as expected and he developed Complex Regional Pain Syndrome (CRPS).

This impacted all areas of his life and he developed low mood due to pain. restriction in activities of daily living (ADLs), leisure and inability to work.

Prior to the accident, the Claimant was fit and healthy, other than hearing loss, and enjoyed running, going on his motorbike and went on active holidays.

I undertook three assessments for this case (which is quite unusual), as his social and health situation altered significantly over the course of the case. From my first assessment, he was restricted in his participation in ADLs and could not touch or wash his leg due to hypersensitivity. He could not sleep upstairs in the same room as his wife. He was very distressed during the assessment and he didn't let me look at or touch his leg.

He needed assistance for tasks such as meal preparation, dog walking, household chores and accessing the community, as he could not drive. Costs for care his family provided were estimated. He was unable to return to work.

At my initial assessment, future support was recommended for household chores. meal preparation (along with equipment) and dog walking.

Occupational therapy, physiotherapy, psychology and vocational rehabilitation were identified as being required to support him to manage his CRPS.

Equipment was recommended, on the basis that his condition was not going to improve in a meaningful way. This was to enable him to be more independent with mobility and ADLs, which could have a positive impact on his psychological well-being.

As the case progressed, the Claimant's social situation altered and his relationship broke down, resulting in him moving house, and by the time of my final assessment, he had undergone a right below knee amputation.

These changes affected my recommendations for care, equipment and accommodation. The medical evidence also altered with regard to his needs in later life.

This case demonstrates that opinion and recommendations can change and a Claimant's situation may change, which impacts on recommendations. The medical evidence is also key, along with your assessment, when forming opinions.

The crucial thing is providing clinical reasoning for your recommendations, so it is clear to you and the reader why you're recommending something.

OTs are ideally suited to this role as we are able to undertake truly holistic assessments and this role allows you to fully utilise this skill. You can be creative in your approach as you're not bound by cost but by what is reasonable.







TOUCH IN THE PERFORMANCE OF ACTIVITIES OF DAILY LIVING



Hand and foot tactile sensations allow us to understand and interact with the world and enable us to perceive surface qualities which are not easily discerned through vision alone. Touch information from contact with surfaces around us is vital for action, providing feedback for fine, dexterous manipulation and enabling whole-body activities like standing and walking, both of which are part of moving and handling.

In the **Active Touch Lab** at the University of Birmingham School of Psychology we take a behavioural neuroscience approach (including psychophysical measurement, functional brain imaging and computational modelling) to the sense of touch. For example, we are looking at the effects of static versus sliding contact in the detection of small irregularities and discrimination of surface roughness with small, controlled changes to the surface. We also simulate how information provided to the brain by different classes of tactile mechanoreceptor changes with aging and evaluate to what extent touch processing involves not only somatosensory but also visual and auditory brain regions in a multisensory cortical network.

Our work includes a focus on understanding the impact of impaired touch on perception and action. For example, we recently published a study¹ of the effects of chemotherapy induced peripheral neuropathy (CIPN) on touch in everyday manual activities such as buttoning clothes and handwriting.

Next year, in collaboration with **Promoting Independence**, we will be holding a 1-day workshop on **Touch in the performance** of activities of daily living. The course will inform clinical practice by sharing new research findings on the sense of touch, delivered though practical demonstrations and lectures, and will develop collaboration between occupational therapists and researchers, by informal poster and discussion groups. Our overall objective, is to support occupational therapists in effectively evaluating their patients, by including how touch impairments affect actions, such as moving and handling everyday objects, as part of improving the quality of life for both patients and their families. For the past decade, Alex Yates' scoliosis and complex needs has made it difficult for him to go beyond his adapted living space.

Now, "the world has opened up" for the 28 year-old and his family: not only can he, for the first time, explore more of his home, but can easily go out and about.

CASE STUDY

TIGHT ON SPACE

Occupational therapists (OTs) frequently face the challenge of meeting user needs while safeguarding carer safety, especially in home environments where space is limited. Recently, Healthcare Matters supported an OT with a particularly complex case.

The client had been using a standard toilet in a very small bathroom. Carers assisting them were often forced to bend and twist awkwardly, which created significant manual handling risks. The OT's goal was clear: reduce carer strain, enable safer working postures, and wherever possible, move towards single-handed care. Healthcare Matters was asked to find a solution that would support the client's independence while fitting the restrictive layout.





THE SOLUTION

After detailed discussions and collaboration with Ropox, Healthcare Matters worked closely with Nicola Zimnoch, UK Area Sales Manager (North), to explore possible options. Together with the OT, the team identified the Ropox Toilet Lifter as the most suitable product. Its compact footprint and smooth height adjustability allowed installation within the confined space without compromising access. Carers could now support the client at an ergonomic working height, while the client gained safer and more independent transfers.

To maximise the benefits, Healthcare Matters paired the toilet lifter with the Geberit AquaClean. Its integrated cleaning function reduced the number of transfers required for personal hygiene, minimising manual handling interventions and saving carers valuable time. Comfort features also allowed the client to remain seated longer without discomfort, improving dignity and reducing care demands.



THE OUTCOME

The installation delivered a safe, space-efficient adaptation that met all priorities:

- Carers can now work in upright, safe positions without twisting.
- The client has greater independence, moving towards single-handed care.
- Transfers for cleaning are significantly reduced.
- The products fit the small bathroom without compromising functionality.

Feedback to Healthcare Matters from both the OT and carers has been overwhelmingly positive. Comments included praise for the "clever use of space" and acknowledgment that they initially did not believe such equipment could fit.

CONCLUSION

This case highlights the value of creative, collaborative problem-solving in adaptations. By working closely with the OT, Nicola Zimnoch, and the Ropox team, Healthcare Matters delivered a tailored solution that improved safety, independence, and dignity for the client. The project demonstrates that even in the most challenging home environments, effective teamwork and the right equipment can transform outcomes for both users and carers.



Being able to sit in the front passenger seat has given Alex a more sociable, interactive travel experience.



MOVINGAND HANDLING, WHY GOOD PRACTICE MATTERS



oving and handling remains one of the most important aspects of providing safe, highquality care. Done well, it protects both the person receiving care and the staff member carrying it out. Done poorly, the risks are significant: injuries, loss of dignity and a breakdown in trust

Early in my career I saw clear examples of both safe and unsafe practice. These experiences highlighted just how easily things can go wrong when correct procedures are not followed and how essential it is to use the right equipment and techniques every time. They also reinforced the importance of speaking up when poor practice is observed, something that can feel challenging in the moment but ultimately safeguards everyone involved

Two particular scenarios come to mind from my time at a previous company prior to GBR. One where a responder manually lifted the lady from underneath her arms, causing her to dislocate her shoulder. This resulted in the responder being dismissed from her role and the customer having

multiple issues afterwards and a newly developed lack of trust in the service. Another incident of unsafe practice was one of my first responses shadowing a trained responder, they manually lifted a man that had fallen beside his bed. This resulted in a skin tear across his arm.

This was reported to management and the responder was dealt with internally. These incidents make you realise that moving and handling is not just about getting from point A to B, it is about keeping all parties safe and protected at all times

Over time, I have supported many individuals who required assistance with moving and handling. My approach has always been to model safe techniques consistently, demonstrating that good practice is not simply about compliance, but about creating a culture of care and respect. When colleagues see correct approaches in action, it builds confidence and creates safe habits across teams.





eing able to transfer in and out of your wheelchair without assistance is essential for living independently. 
